<p>Terms & Conditions of this Agreement</p> <p>IMPORTANT - YOU SHOULD READ THIS CAREFULLY</p>	<p><u>Ownership of Goods</u> During the hire period the saxophone & accessories remain the property of the Owner. You must not sell or dispose of them.</p> <p><u>Insurance & Responsibility</u> The Hirer is responsible for any loss or damage to the saxophone or accessories. In the event of theft or loss the sax's total value of £250 must be paid in full. In the event of damage the Hirer will be responsible for the cost of repair. Therefore, it is recommended that you insure the saxophone. In most cases it can be added to a home contents policy for very little cost.</p> <p><u>Care of the Saxophone & Accessories</u> The Hirer must take reasonable care to ensure that the sax and accessories are secure, adequately maintained and not liable to misuse. The Owner must be notified immediately of any loss or damage.</p> <p><u>Hire Term</u> The Hirer agrees to hire the saxophone for the hire term.</p> <p><u>Return of the sax</u> It is the Hirer's responsibility to return the sax & accessories (except the reed) safely and in equal condition to when they were hired by the end of the Hire Term. Late returns will incur an additional fee of £12 per day.</p> <p><u>Payment</u> Payment is non-refundable. A receipt of payment will be issued in addition to this agreement by email from the Owner to the Hirer.</p> <p><u>Change in your details</u> The Owner must be notified immediately of any change of address, phone number or employment details of the Hirer.</p> <p><u>Cooling off period</u> You have a 14 day cooling off period during which you have the right to return for a refund. The sax must be returned safely at your cost in equal condition to when it was hired.</p> <p><u>Declaration by Hirer</u> The Hirer agrees and accepts that they have read and agree to be bound by the terms and conditions stated herein.</p>
